***Please read each statement below carefully & then sign below to agree to all conditions:***

- ❖ Owner has provided proof of current rabies (mandatory), distemper (mandatory), and kennel cough (strongly encouraged) vaccines and/or understands the risks of not having these vaccines while their pet boards. We highly encourage any vaccines your vet recommends for boarding in this area.
- ❖ Owner agrees to be solely responsible for any and all acts of behavior of their pet while it is in our care and/or while being groomed. (ex. property/supply damage, injuring themselves, etc)
- ❖ Owner agrees that *unless you tell us otherwise*, your pet will be given a thick foam mat and fleece blankets to lay on while they are in our care. If your dog chews and swallows these items, or any other items you bring for them while they are in our care (like toys, chew bones, beds, blankets, etc), we are not liable for any issues that result from that during or after their stay.
- ❖ Owner understands that even if their pet has received the kennel cough (Bordetella) vaccination, their pet is still at risk of becoming infected due to being in close proximity to numerous dogs. The vaccine does not protect your pet from all strains of kennel cough. Owner agrees to not hold us responsible if their dog is diagnosed with kennel cough during or after their stay. This also goes for any other disease, like distemper, parvo, canine influenza, coronavirus, etc.
- ❖ Owner agrees to pay all costs and extra charges for special services requested (ex. grooming), extended stays past original departure date, baths due to flea/tick problems, property damage, etc.
- ❖ Owner agrees that if their pet becomes ill or seems to be in need of medical attention, the facility reserves the right to administer aid with any available veterinarian. Owner also gives us consent to sign for any medical care including anesthesia and agrees to pay for all veterinary costs when they pick up their pet. We usually use Mass RI Vet ER in Swansea, MA for emergencies.
- ❖ Owner understands that if an elderly or ill dog is brought in for boarding, it will be under more stress than normal, which may intensify pre-existing health issues and lead, in extremely rare cases, to fatality due to sudden change in environment. Owner agrees to not hold us responsible if their dog becomes increasingly ill or passes away during or after their stay.
- ❖ A pet that is unclaimed at our facility for 7 days beyond its scheduled discharge date without contact from the owner is considered abandoned, and will therefore become the property of our facility. Every effort will be made to contact the owner in this scenario. Owner agrees to contact us immediately if their dog needs to remain at our facility longer and agrees to pay the daily rate until their pet is picked up.
